**As of February 2014, the RPC staff has trained 247 individuals in Responsible Beverage Service and Sales (RBSS) training throughout our region since August 2013. We appreciate all of our establishments who have participated in this training!**

**RBSS is a program that was developed through the ABLE Commission and the Oklahoma State Department of Mental Health and Substance Abuse Services. The goal of RBSS is to train store clerks, servers, bartenders, and management of establishments that serve alcohol the basic knowledge and skills to practice responsible alcohol sales and services. RBSS Trainings will be conducted across the state.**
