Safe Disposal of Unused or Expired Prescription Medicines

Prescription drug abuse is Oklahoma's fastest growing drug problem and according to Oklahoma's Injury Prevention Service, from 2012-2016, Canadian County had 35 unintentional deaths related to prescription painkillers (opioids).

Our prevention initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—both pose potential safety and health hazards

One way to be a part of the solution is disposing of prescription drugs properly. The Oklahoma Bureau of Narcotics and Dangerous Drugs (OBNDD) has many drop off boxes for people to securely and safely dispose of any unused, unwanted, or expired prescription drugs. According to Mark Woodward with OBN, "Prescription drug abuse is a growing epidemic in Oklahoma. It's unnecessary and unsafe to leave outdated drugs in the house. Old, expired medications left in the home can be targeted by users. Teenagers also target their parent's current or expired prescription drugs to abuse, trade or sell in order to obtain alcohol, marijuana or other drugs."
